

## 2015 City Budget: Your input needed!

The City's annual operating budget approximates some \$140 million in revenues and expenditures across some 37 different funds. The other significant part of the City's total budget is the Capital Improvement Plan (or CIP) which typically includes some \$20-\$40 million in spending for large projects or "one-time" purchases each year. The Council will normally begin to receive proposed budget information for the ensuing year in October and the City's proposed preliminary budget must be made available to the public at least six weeks prior to January 1 (November 13, 2014) of the budget year. To make these deadlines and afford the City Council time to evaluate the proposed budget, the process of budget development begins in late spring of each year for City staff.

Responding to City Council goals and direction, laws or regulations of the state and federal governments, and the needs of the community, the directors and managers in each department begin by spring to develop lists and preliminary costs of programs and/or projects for the ensuing year.

In early summer, the City Council considers the proposed six-year CIP which identifies "near certain" spending plans and revenue sources for projects in early years, with less firm projects for later years of the plan. Revising and adopting a six-year plan each year helps the City to focus both on short-term projects as well as prospective longer-term projects, together with their costs, scope and

timetables. The City's 2015-2020 CIP was adopted in July and identifies some \$27 million in construction projects or large purchases in 2015.

With large project expenditures identified in the CIP, staff continues to work through the summer and into September to develop the proposed operations budget. While expenditures include personnel costs, utilities, materials and supplies as well as a host of other categories, the total expenditures in each fund must be offset by equal revenues which are legally available to the respective fund. By law, the City's budget must be balanced for each fund, and in total.

The City's general fund, which is the largest (accounting for approximately 30% of all City expenditures) and provides services such as police, fire, parks, municipal court and other general government operations, is funded primarily by City taxes on property, retail sales, and utility services.

The City Council is scheduled to hold a public hearing on revenue sources for the budget on Monday, November 17, 2014. The final public hearing, prior to Council adoption of the 2015 Operating and Capital Improvement Budgets, is scheduled for Monday, December 1.

# Three Rivers Park Shows the Value of Cooperation

The City and the Pasco School District are again joining forces to build a combined school and public park facility, this time at Road 60 and Sandifur. Taxpayers of both agencies save valuable construction dollars due to the combining of these projects. The park is designed to function under new safety constraints of having the school use area fenced off during school hours, while keeping the play area, basketball court, and picnic shelters available to the general public. However, the fenced playfield will be open during non-school hours like any other park. The City plans to spend \$420,000 to build the park, while the District will pay for the fence that surrounds the playfield. The City and the District will also share maintenance and upkeep costs, another "win-win" for the citizens of Pasco. # City Takes Over Sewer Pretreatment Program

Due to the recent growth of Pasco, the Washington State Department of Ecology (DOE) is requiring the City to manage its own Industrial Sewer Pretreatment Program, which was previously handled by DOE. A pretreatment program helps identify potential industrial uses of the sewer system which may affect the City's sewer discharge into the Columbia River. All businesses within the City of Pasco boundaries will be subject to the City's Pretreatment Program, effective in January 2015. For most businesses, the only impact will be to periodically complete a required "Industrial User Screening" form. Businesses which generate wastewater, which could potentially negatively affect the wastewater treatment plant, may be subject to additional monitoring and may need to be permitted. A mailer with the screening form was sent to all Pasco businesses on record and an open house was held in August to answer questions from the business community and public.
