
Energy-Efficient Streetlights Coming to Pasco



pproximately one-third of the streetlights throughout Pasco will soon be changed from the traditional high pressure sodium lights to induction streetlights, which will provide significant cost savings in both energy use and fixture longevity.

In late 2009, Pasco received a \$495,000 federal Energy Efficiency Conservation Block Grant (EECBG) from the U.S. Department of Energy. To be eligible to spend the grant money, the City completed an Energy Conservation Inventory and Strategy, which identified the replacement of streetlights for potential energy savings. On average, induction lights would save an estimated 52 percent of streetlight energy use and are expected to last three to four times longer than the lights currently in place.

There are some 3,700 streetlights throughout the city. Franklin PUD maintains the lights and charges the city a monthly fee calculated to include both energy and re-lamping/replacement costs. It is estimated that if all of the streetlights were replaced, annual savings could be approximately \$120,000 of the current \$223,000 annual streetlight expense (a savings of nearly 54%).



The federal funding, combined with rebates from the Bonneville Power Administration for energy efficient upgrades, will allow for a first phase replacement project of approximately 1400 (38%) of the existing streetlights in the city. First phase electrical savings are expected to be 550,000 kilowatt hours per year with cost savings estimated at \$40,000 annually. A second replacement phase is planned, adding an additional \$80,000 estimated annual savings as all lights are upgraded.

The streetlights slated for replacement in the first phase are primarily in residential areas.

Replacement work is expected to begin this summer with completion estimated for September.

Beautiful Yards Recognition Continues

Since 1990, the City of Pasco has recognized Pasco citizens for outstanding contributions to the overall appearance of our community. This recognition is accomplished through the Yard of the Month program, which is held during the months of May through September.

The City is divided into four geographic regions with a residential Yard of the Month award given in each region every month. In 2006, the City also initiated the Business Appearance Award which recognizes one business in the community per month.

Judging for the awards is accomplished by volunteers in the community. The judging criterion, as applicable, includes



mowed and trimmed grass, pruned trees and shrubbery, weed-free flower beds, and overall appearance of the property.

New Equipment Helps with Graffiti Removal

A new hot water pressure washer is helping the City remove graffiti more efficiently.

The equipment has its own trailer, its own generator and longer hoses. In the past, the City had a cold water pressure washer, but the use of hot water improves effectiveness and reduces the need to use expensive chemicals in graffiti removal. The equipment was paid for through the City's Nuisance Abatement Fund which receives penalties assessed by the City's Code Enforcement Board for property maintenance violations.

In 2010, the City had over 3,000 known graffiti locations. When information is received about graffiti, before it can be removed, City officials must receive permission to remove it if it is on private property. This is often delayed as the owner awaits insurance information. Removal can also be delayed by inclement weather or difficult, inaccessible graffiti locations.

Getting a permit helps ensure your project complies with City codes, meets minimum safety and other standards and provides an important record of improvements for insurance and other purposes.
